The business objective for BP of the Khazzan Project is to then develop and operate a 29.8 million Sm3/d (1,050MMscfd) tight gas development in Block 61.

The O&M engineer is responsible to ensure that HSSE requirement are applied and followed by everyone. He should make sure that proper information is passed to everyone and that risks are limited at all time.

The O&M engineer is responsible to establish a good working atmosphere for all the staff present at the Veolia LLC facilities (Employees and subcontractors).

Key Responsibilities

- Operate and monitor the plant operation,
- To monitor and ensure the highest quality of treatment,
- To establish methods to meet regulatory requirements,
- With the operator inspect all equipment, check chemical dosing rate and chemical stocks,
- Calibrate instrument and analyzer link to the process,
- Manage and support maintenance team in their routine and breakdown maintenance duties,
- Follow and manage the CMMS Software,
- Coordinate contractors,
- Assist in plant optimization and share responsibility for the plant good performance,
- Record all necessary information, data which support the operation and maintenance activity in order to establish reporting,
